NOTIFICATION

Subject: Development of earth crack and occurrence of landslide in areas of Tlakshi village under Vanghmun TK, Kanchanpur, North Tripura - urgent consideration for declaration of disaster

In reference to the cited subject matter, it has come to attention that a critical situation is unfolding within the said stipulated areas. A technical team, comprised of experts from various pertinent fields, was constituted by the State Government on July 26, 2023, to address a pressing concern.

- 2. The technical team has diligently carried out site visits on three occasions July 28, 2023, August 6, 2023, and August 19, 2023. The observations from these visits have unveiled an alarming escalation in the severity of the issue. The existing cracks have expanded significantly, and the soil has started to destabilize, posing an imminent threat of a substantial landslide. As of now total 25 families have been affected and 8 families have been evacuated to safer places.
- 3. Based on the comprehensive report submitted by the technical team, the district administration has undertaken all feasible precautionary measures as per the items and norms of expenditure of State Disaster Response Fund (SDRF). However, it has become evident that the gravity of the situation surpasses the administrative and financial capacities of the district administration. Thus, the need for immediate intervention at the state level has become imperative. Further, there is a need to explore whether State Disaster Mitigation Fund (SDMF) or any other fund from other sources may be utilized to tackle the situation a part from SDRF.
- 4. In light of the severity of the circumstances, the undersigned is directed to declare the incident as disaster as per approval of the Chief Secretary being the Chairman of the State Executive Committee (SEC) under Tripura Disaster Management Authority (TDMA) vide UO NO.2082-CS/2023 dated 22 August 2023 for taking swift and effective administrative actions to mitigate the impending risks.
