### SELECTION CRITERIA FOR HIRING OF VEHICLE

The undersigned is directed to invite rates from resourceful and bonafied vehicle owners/ Firm for hiring of 1 (one) Maruti Ertiga ZDI (CNG) Vehicle for (24 x 7 hour basis) duty on the following terms & conditions:-

- (i) The rate should be quoted for detention per day and run per km in the form prescribed at ANNEXURE-I.
- (ii) The rate should not exceed the upper ceiling as mentioned in DFPRT, 2019 i.e., per day detention charge Rs.1,000/- and @ Rs. 5/- per km run (CNG), OT can be claimed if the vehicle will be used beyond office hour as per norms.
- (iii) Selection Criteria to detect the Lowest-1 bidder would be as follows:a) Maximum number of Working days in a month i.e. 23 days (as per DFPRT-2029) X detention charge quoted by the bidder + maximum distance covered by a vehicle in a month (km) i.e. 1840 (as per DFPRT-2019) X per km rate quoted by the bidder. - (iv) The vehicle should have all valid documents as well as commercial license & Certificate of Insurance as per Motor vehicles Act.
- (v) The vehicle should be in very good condition and its manufacturing date not older than 01-01-2023, preferably 01.01.2024 for the sake of smooth & proper journey.
- (vi) Amount should be written both in figures and words.
- (vii) Providing fuel, lubricants, dusters and maintenance etc. for the vehicle will be the responsibility of the supplier.
- (viii) The vehicle should be placed within 7 (seven) days from the date of issue of final order.
- (ix) The supplier will provide minimum accessories for the vehicle;
- (x) The driver should be given prescribed liveries by the supplier;
- (xi) In case of need, the driver has to be changed within 24 hours of being informed and if the vehicle is not available on any day no payment (Haltage charge) would be made for the day;
- (xii) In case of repair, a similar vehicle shall have to be provided by the supplier as replacement during repair period;
- (xiii) Payment of hiring charges will be on monthly basis against bill raised by the supplier supported by appropriate certificate from the user;
- (xiv) Tax will be deducted from the bill as per rules;
- (xv) The concerned parties shall have to submit PAN Card and GST Registration.
- (xvi) The tenderer will have to deposit an amount of Rs.5,000/- (Rupees five thousand) only as earnest money in the shape of Bank Draft / Deposit at Call drawn in favour of the DDO, RR&DM(Revenue Department). The Tender will be treated as informal without earnest money.
