**MEMORANDUM**

Subject: Extending interim relief pending final assessment and assistance as per SDRF

Letter NO.33-03/2020-NDM-I dated 11 July 2023 may be referred under which revised list of items and norms of assistance from SDRF/NDRF formulated by the Government of India for the period 2022-23 to 2025-26. The same has already been circulated to all the districts for information and necessary action. 2. In accordance with the earlier items and norms of assistance the consolidated circular for interim relief issued vide Memorandum NO.F.12(3)-REV/15FC/SDRMF/2020 dated 26 April 2021 is hereby modified for extending interim relief pending final assessment during any notified centre specified/state specified natural disasters as under:

1	In case of death	Rs.4,00,000/-	Rs.20,000/- by DBT.
2	In case of serious/grievous injury requiring hospitalization	Rs.16,000/- requiring hospitalization for more than a week. Rs.5,400/- requiring for less than a week. Note: Injured persons getting treatment under the "Ayushman Bharat Yojna" will not be eligible for relief under this item.	Rs.2,500/- by DBT.
3	Clothing & utensils/Household goods for families taking shelter in relief camps	Rs.2,500/- per family for loss of clothing. Rs.2,500/- per family for loss of utensils/household goods	The upper limit is Rs.5,000/- by DBT where both clothing and utensils are covered
4	House Damage Fully damaged/destroyed pucca house and kutcha house	R.1,20,000/- per house in plain areas.	For plain areas - Rs.20,000/- as interim relief. Thereafter, Rs.50,000/- may be given for starting the construction. Balance

	Severely damaged pucca house and kutcha house	Rs.1,30,000/- per house in hilly areas.	Rs.50,000/- may be given after completion of the plinth level. For hilly areas - Rs.20,000/- as interim relief. Thereafter, Rs.55,000/- may be given for starting the construction. Balance of Rs.55,000/- may be given after completion of the plinth level. Payment to be made by DBT.
