## **MEMORANDUM**

Subject: Gratuitous relief for families whose livelihood is seriously affected

Letter NO.33-03/2020-NDM-I dated 11 July 2023 may be referred under which revised list of items and norms of assistance from SDRF/NDRF formulated by the Government of India for the period 2022-23 to 2025-26. The same has already been circulated to all the districts for information and necessary action. 2. In accordance with the earlier items and norms of assistance criteria of GR issued vide Memorandum NO.F.12(5)-REV/SDRF/2010 (Loose) dated 16 December 2020 is hereby modified for extending gratuitous relief for families whose livelihood is seriously affected during any notified centre specified/state specified natural disasters as under:

			States/UT per day whichever is lower. Payment mode would be DBT.

- 3 . Besides existing terms and conditions, the revised rate of GR is subject to further following conditions:
  - i. Expenditure on this account shall not exceed 30% of SDRF allocation for the year under the window "Response and Relief" for all centre specified and state specified disasters except drought. In the case of drought expenditure on this account shall not exceed 50% of SDRF allocation for the year under the window "Response & Relief".
  - ii. To calculate the average rate as cited in above table, notification issued by Ministry of

- Rural Development from time to time is to be referred.
- iii. To avoid duplication of benefits in a geographical unit (Village/colony), GR shall not be provided to those persons who are housed in relief camps.
- iv. GR shall be credited to the beneficiary bank account through DBT mechanism using PFMS or a state DBT portal.
- v. To ensure transparency, the list of persons to whom GR is provided should be uploaded on the website of the concerned districts and
- vi. The concerned DM & Collectors shall notify the basis and process for identification of beneficiaries district wise in a transparent manner.
- 4. As such the Memorandum NO.F.12(5)-REV/SDRF/2010 (Loose) dated 16 December 2020 is hereby superseded. This instant Memorandum shall come into effect from the date of issuance of it.
